"7-ELEVEN x CROCS" PROMOTION

TERMS AND CONDITIONS

- 1. Information on how to enter this competition (**Promotion**) forms part of these Terms and Conditions. Participation in this Promotion is deemed acceptance of these Terms and Conditions.
- 2. Entry is only open to Australian residents aged 16 years or over who have an Instagram account.
